You may wish to supplement the request with a description of the reasons behind it.

While the Huntington Beach adoption order was filed in the docket on the day of its approval by the Commission, most other recent adoption orders and decisions were filed on the Monday following Commission action, which has been our general practice. See the Blythe Solar Amendment (09-AFC-06C, adopted 1/15/14, filed 1/21/14); Bottlerock Amendment (79-AFC-04C, adopted 12/11/13, filed 12/16/13); Pio Pico (11-AFC-01, adopted 9-12-12, filed 9-17-12); Watson (09-AFC-01, adopted 4/11/12, filed 4/16/12); Palmdale (08-AFC-09, adopted 8/10/11, filed 8/15/11); and Oakley (09-AFC-04, adopted 5/18/11, filed 5/23/11). Similar to Huntington Beach, the Carlsbad Amendment (07-AFC-06C) was adopted and filed on the same day–11/12/15; The Carlsbad AFC (07-AFC-06) order was filed one day after its adoption on 5/31/12.
