Notice of Community Forum

The Lithium Valley Commission will host a community forum on Tuesday, November 17, 2021, from 6:00 to 8:00 p.m. with Spanish and Purépecha interpretation available. This community forum is being held to provide an overview about and introduction to the Lithium Valley Commission and the concept of the Lithium Valley and seeks to engage the community directly and encourage public participation in the efforts of the Lithium Valley Commission.

The community forum will be conducted as a remote meeting, consistent with Assembly Bill 361 (Rivas, Chapter 165, Statutes of 2021) to improve and enhance public access to state agency meetings during the COVID-19 pandemic by allowing broader access through teleconferencing options. Four physical locations have been arranged to support community access to the remote forum. The public can participate in the forum using the remote attendance instructions provided below or attend the in-person locations where access to the remote forum will be provided.

Background

Lithium is a critical resource to enable the transition to a clean energy economy. It is a crucial component of the batteries needed for electric vehicles and grid electricity storage. Demand of lithium is projected to increase significantly in the next decade,

driven by increasing global need for batteries. Today, 95 percent of all lithium is produced in just four countries: Australia, Chile, China, and Argentina. The lithium resource in Imperial County, if extracted from geothermal brine, could generate a substantial in-state supply of lithium with the potential to meet more than one-third of global lithium demand (U.S. Geological Survey, 2020).

Assembly Bill 1657 (AB 1657) (Garcia, Chapter 271, Statutes of 2020) authorized the CEC to convene a Blue-Ribbon Commission on Lithium Extraction in California, referred to as the Lithium Valley Commission. The Lithium Valley Commission is charged with reviewing, investigating, and analyzing certain issues and potential incentives, as detailed in the statute, regarding lithium extraction and use in California. Additionally, the Lithium Valley Commission is required to submit a report to the legislature documenting its findings and recommendations on or before October 1, 2022.
