Staff Report on the Amendment Proposal for the California State Pipe Trades Council Acceptance Test Technician Provider Application CEC-400-2021-016 Docket # 13-ATTCP-01

The California State Pipe Trades Council (CSPTC) submitted to the California Energy Commission (CEC) an application amendment on September 15, 2021. Per the requirements in Section 10-103.2(f) of the Building Energy Efficiency Standards (Energy Code), acceptance test technician certification providers (ATTCPs) may submit an amendment to their approved application. Amendments submitted after approval of an ATTCP's application that contain any substantive changes shall be subject to the Application Review and Determination process specified in Section 10-103.2(e).

CEC staff has evaluated the amendment application that the CSPTC submitted and has determined that the proposed changes to applicant prerequisites outlined in the amendment satisfy the requirements for acceptance test technician applicants in Section 10-103.2(c)3Biii of the 2019 Energy Code. Staff recommends approval of the CSPTC's application amendment.
