Air Movement and Control Association (AMCA)¹ International thanks the California Energy Commission (CEC) for publishing the Regulatory Action and Notice of Proposed Action (NOPA) for the Title 20 Commercial and Industrial Fans and Blowers rulemaking, and for the opportunity to comment on the draft regulatory language.

AMCA International has been working collaboratively on the rulemaking with the CEC, California Investor Owned Utilities, and other stakeholders since the rulemaking's inception in 2017. AMCA is committed to helping the CEC fashion a regulation that will aid California in its energy and climate goals while also being fair to industry and consumers.
