RESOLUTION: CITY OF ORANGE COVE (CITY)

RESOLVED, that the State Energy Resources Conservation and Development Commission (CEC) adopts the staff CEQA findings contained in the Agreement or Amendment Request Form (as applicable); and

RESOLVED, that the CEC approves Agreement 004-21-ECI with the City of Orange Cove (City) for a \$2,228,616 loan at one percent simple interest to install a solar array at the City's wastewater treatment plant and LED lighting at seven City sites. Upon project completion, the project is estimated to reduce about 961,534 kWh of grid electricity consumption annually, saving the City approximately \$142,166 in utility costs per year; and

FURTHER BE IT RESOLVED, that the Executive Director or their designee shall execute the same on behalf of the CEC.
