Pursuant to COM-4, and as part of Geysers Power Company’s (“GPC”) ongoing efforts to keep the Energy Commission informed of fire system recommissioning activities at the Geysers, GPC is providing this report summarizing the recommissioning activities at Sonoma, Unit 3 (80-AFC-01C), Lakeview, Unit 17 (79-AFC-03C), and Calistoga, Unit 19 (81-AFC-01C), collectively referred to herein as “the Geysers.” This report covers recommissioning activities during March 2022 (March 1-31, 2022) and provides recommissioning schedule updates.
