Dear Mr. Bohan:

Pursuant to Sections 2501 *et seq.*, of Title 20 of the California Code of Regulations, Geysers Power Company's ("GPC") hereby submits this Repeated Application for Confidential Designations for Appendices A and B to the March 2022 Monthly Recommissioning Report for the Geysers geothermal power plants named above, hereinafter "Repeated Application."

By your letter dated February 2, 2022, the confidential appendices A and B to GPC's monthly recommissioning reports previously submitted, and which include details of ongoing construction work and the schedule of work at each power plant site, were determined to be confidential for two years from the report date.<sup>1</sup> This Repeated Application similarly seeks confidential designation for Appendices A and B to the March 2022 Monthly Recommissioning Report consistent with the two-year confidentiality protection provided in the February 2<sup>nd</sup> determination. This Repeated Application is being submitted because Appendices A and B to the March 2022 Monthly Recommissioning Report contain information that is substantially similar to the previously submitted information that was granted confidential designation for a period running two years from the report date, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.
