## **Approval by the Executive Director of Right-Energy Title 24 Version 2019.2.0 Compliance Software**

### **Docket # 19-BSTD-01**

The executive director hereby approves Right-Energy Title 24 Version 2019.2.0 as an update to Right-Energy Title 24 Version 2019.1.1, which incorporates the new version of the California Building Energy Code Compliance, Residential (CBECC-Res) compliance manager, pursuant to Sections 1.2.1 and 1.3.1 of the 2019 Alternative Calculation Method (ACM) Approval Manual.

On February 20, 2020, the California Energy Commission (CEC) approved Right-Energy Title 24 Version 2019.1.1 as an alternative calculation method for demonstrating performance compliance with the single-family residential new-construction provisions of the 2019 California Energy Code (Energy Code). When the CEC approved Right-Energy Title 24 Version 2019.1.1, it directed the executive director to, among other things, "review and approve updates to vender software, consistent with Section 1 of the 2019 ACM Approval Manual."

On September 8, 2021, the CEC approved CBECC-Res 2019.2.0 as the public domain software for estimating energy consumed by residential buildings under Public Resources Code section 25402.1(a), for demonstrating compliance with the performance-based provisions of the 2019 Energy Code.

On February 7, 2022, MiTek Wrightsoft submitted an application to the CEC for approval of Right-Energy Title 24 Version 2019.2.0 as an update to its compliance software which incorporates the CBECC-Res 2019.2.0 compliance manager and contains functionality for single-family residential new-construction compliance. The application contained the elements required by Section 1.1 of the 2019 ACM Approval Manual and CEC staff determined that the application was complete and able to be approved.
