ConSol Home Energy Efficiency Rating Services, Inc. (CHEERS) submitted the final revisions of CHEERS' application to use Archon Energy Solutions Compass external digital data source (EDDS) service to the California Energy Commission (CEC) on February 8, 2022.

CEC staff completed its review of the application and determined that it complies with the applicable requirements of the 2019 Energy Code. A staff report about the review and evaluation of the application was published, and a notice informing interested parties that the report was available on the CEC website was transmitted on April 25, 2022.

Based on staff's review and validation of CHEERS' application to use Archon Energy Solutions Compass EDDS, I find that the application meets the applicable requirements of the 2019 Energy Code. I also find that the application meets the conditions for streamlined approval as specified in Reference Joint Appendix JA7.8.3.2. Therefore, I approve CHEERS' application to use the Archon Energy Solutions Compass EDDS service.

This approval allows CHEERS to make the Archon Energy Solutions Compass EDDS service available for use as an option for keyed-in data entry for CHEERS' data registry, along with the addendum to the user manual. CHEERS shall notify authorized users of the data registry when the EDDS service has been made available as specified in JA7.8.3.2(d).
