Re: *California Code of Regulations, Title 24, Part 1 10-103.2 – Nonresidential Mechanical Acceptance Test Training and Certification, Section (d) Requirements for ATTCPs to Provide Regular Reports*

Dear Dockets Unit:

This concerns National Energy Management Institute Committee as the California Energy Commission-approved Acceptance Test Technician Certification Provider under *California Code of Regulations, Title 24, Part 1 10-103, specifically Section (d) Requirements for ATTCPs to Provide Regular Reports*.

As indicated in our ATTCP Certification Manual, any significant changes to the Building Energy Efficiency Standards (“Standards”) trigger the requirement for recertification. Towards that goal, we have developed a webinar, a copy of which is attached, that each NEMIC ATTCP-certified Acceptance Test Technician (ATT) and Acceptance Test Employer (ATE) will have to attend to recertify. ATTs and ATEs will have to complete the respective 2016 Recertification Statement (copies of which are attached) stating that a) they have attended the webinar; and b) that their respective qualifications have not changed. If they do so before January 1, 2017 their certification status will not change. If they fail to meet that deadline, their status will change to “decertified” and their name, and in case on an employer, their affiliation, will be removed from the list of certified ATTs or ATEs from our ATTCP website at [www.attcp.org](http://www.attcp.org). A notice will be posted on our website calling for recertification by all certified ATTs and ATEs after the California Energy Commission approves our proposed webinar.

Our certification exams for ATTs and ATEs will be updated to reflect the changes from the 2013 Standards to the 2016 ones. The updated certification exams will be submitted to the Energy Commission Docket Unit with an Application for Confidential Designation per Title 20 CCR § 2505 et seq. under a separate filing.
