**I. NOTICE OF AVAILABILITY**

On May 27, 2022, the Committees<sup>1</sup> appointed by the California Energy Commission (CEC) to conduct proceedings on the Applications for Certification (AFC) for the Pecho Energy Storage

Center (Pecho)<sup>2</sup> and the Gem Energy Storage Center (Gem)<sup>3</sup> filed a Proposed Joint Decision Regarding Exemption from the Notice of Intention Process (Proposed Decision). Following the end of the comment period, the Committees, if appropriate, may prepare errata describing changes to the Proposed Decision it recommends after its consideration of comments from the parties and the public.

### III. NOTICE OF INTENT TO PREPARE HEARING RECORD

In preparing the Proposed Decision, the Committees relied on facts, opinions, and other information contained in the dockets for both the Pecho and Gem proceedings. The Committees hereby inform the public and the parties that the Committees consider the dockets in Pecho and Gem to be the hearing record<sup>4</sup> for the Proposed Decision.

<sup>4</sup> Under the CEC’s regulations, the hearing record consists of: (1) all documents, filed comments, materials, oral statements, or testimony received into evidence by the committee or commission at a hearing; (2) public comment, including comments from other government agencies, offered orally at a hearing, or written comments received into the record at a hearing; (3) any materials or facts officially noticed by the committee or commission at a hearing; and (4) all transcripts of evidentiary hearings. (Cal. Code Regs., tit. 20, § 1212(b)(1).)

Any party<sup>5</sup> may file an objection to the inclusion of one or more documents from the Pecho and Gem dockets. The parties are **ORDERED** to file any objection no later than **5:00 p.m. on June 6, 2022**. The objection shall identify the document being objected to by reference to its TN and shall specify the grounds for the objection. Failure to object to the inclusion of a document in the hearing record shall be deemed a waiver of objections to the admissibility of the information and its use by the Committees and the CEC in deciding whether Pecho and Gem are exempt from the Notice of Intention process.

#### **IV. NOTICE OF CEC HEARING AT THE BUSINESS MEETING**

**PLEASE TAKE NOTICE** that the CEC will conduct a public hearing at the June 8, 2022 Business Meeting to consider the Proposed Decision (which recommends finding that Pecho and Gem are exempt from the Notice of Intention process and shall proceed as applications for certification), any errata, and comments. The purpose of this hearing is to consider whether the CEC should adopt, modify, or reject the Proposed Decision and any errata. Parties and members of the public may participate and offer oral and written comments on the Proposed Decision.

If the Proposed Decision is adopted, the CEC will compile a Final Commission Decision that incorporates the CEC Adoption Order, the Proposed Decision, any errata, and any modifications made by the CEC during the Business Meeting into a single document for the convenience of the parties and the public.
