## About the Speakers

### **Dr. Manuel Pastor**

Dr. Manuel Pastor, the Distinguished Professor of Sociology and American Studies & Ethnicity and the Director of the Equity Research Institute at the University of Southern California, will provide keynote remarks.

Dr. Pastor's research has generally focused on issues of the economic, environmental, and social conditions facing low-income urban communities — and the social movements seeking to change those realities. He has authored multiple books, including [Solidarity Economics: Why Mutuality and Movements Matter](https://solidarityeconomics.org/se-book/), co-authored with Chris Benner, (available at <https://solidarityeconomics.org/se-book/>) and [South Central Dreams: Finding Home and Building Community in South L.A.](https://www.southcentraldreams.com/), co-authored with Pierrette Hondagneu-Sotelo (available at <https://www.southcentraldreams.com/>). Dr. Pastor's previous book, [Equity, Growth, and Community: What the Nation Can Learn from America's Metro Areas](http://growingtogethermetro.org/) (available at <http://growingtogethermetro.org/>), co-authored with Chris Benner (UC Press 2015), argues how inequality stunts economic growth and how bringing together equity and growth requires concerted local action. ### **Silvia Paz and Dr. Chris Benner**

Silvia Paz, the Executive Director of Alianza Coachella Valley (Alianza), and Dr. Chris Benner, Professor of Environmental Studies and Sociology at the University of California, Santa Cruz and the current Director of the Everett Program for Technology and Social Change and the Institute for Social Transformation, will provide a joint presentation about the localized indicators work they are conducting in the Salton Sea region that takes a "solidarity economics" approach to address widening income inequality, rising economic insecurities, and growing social and racial fragmentation while also promoting innovation and economic growth.

Dr. Benner's research examines the relationships between technological change, regional development, and the structure of economic opportunity, focusing on regional labor markets and the transformation of work and employment. He has authored or co-authored seven books and more than 75 journal articles, chapters and research reports.
