NOTICE OF COMMITTEE CONFERENCE (CLOSED SESSION); NOTICE OF PUBLIC COMMENT PERIOD ON UPDATED AIR QUALITY ANALYSIS; ORDER SHORTENING TIME; ORDER REGARDING UPDATED INFORMATION ON TRIBAL CONSULTATION

In April 2021, Vantage Data Centers (Applicant) submitted an application for a small power plant exemption (SPPE) for the CA3 Backup Generating Facility (Application)¹ to the California Energy Commission (CEC). Applicant proposes to construct and operate the CA3 Backup Generating Facility (Backup Generators) to provide an uninterrupted power supply for the CA3 Data Center (Data Center). Applicant will also construct an electrical substation for use by Silicon Valley Power, the local power provider. The Backup Generators, Data Center, substation, and other features are referred to as the "Project."

PURPOSE OF THE COMMITTEE CONFERENCE

The Committee Conference (Closed Session) will be held for the primary purpose of conducting Committee deliberations in closed session. The open meeting will be convened, public comment will be taken, and then the closed session will begin. The open meeting will reopen at the conclusion of the closed session for the purpose of disclosing any reportable action taken in closed session.

NOTICE OF CLOSED SESSION DELIBERATIONS

The Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.

II. NOTICE OF PUBLIC COMMENT PERIOD ON UPDATED AIR QUALITY ANALYSIS

BACKGROUND

CEC staff (Staff) published a Final Environmental Impact Report (Final EIR) for the Project on March 24, 2022.³

On May 27, 2022, the Committee held an Evidentiary Hearing.⁴ At the conclusion of the Evidentiary Hearing, the Committee requested that Staff, in consultation with Applicant, prepare a supplement to the Final EIR that incorporated an updated analysis of the cumulative health risk assessment in the Air Quality section of the Final EIR, based on the testimony and other evidence admitted during the Evidentiary Hearing.⁵

On June 22, 2022, Staff filed a Memorandum and Update to Air Quality Section of FEIR (June 22 Update). The June 22 Update contained revisions to the Air Quality section based on the

Committee's direction at the Evidentiary Hearing. The June 22 Update included three refinements: a reduction of the radius used to analyze the health impacts of the Project from 2,000 feet to 1,000 feet; reduction of the background emissions from the nearby Caltrain rail line based on an electrification project; and a reduction of the amount of time a worker would be exposed to emissions from the Project.⁶

DISCUSSION

Under the California Environmental Quality Act (CEQA),⁷ if the lead agency adds "significant new information" to an EIR after the close of the public comment period but before certification of the final EIR, the lead agency must provide a new public comment period.⁸

Significant new information requiring recirculation includes, for example, a disclosure showing that:

- (1) A new significant environmental impact would result from the project or from a new mitigation measure proposed to be implemented;
- (2) A substantial increase in the severity of an environmental impact would result unless mitigation measures are adopted that reduce the impact to a level of insignificance;
- (3) A feasible project alternative or mitigation measure considerably different from others previously analyzed would clearly lessen the significant environmental impacts of the project, but the project's proponents decline to adopt it; or
- (4) The draft EIR was so fundamentally and basically inadequate and conclusory in nature that meaningful public review and comment were precluded.⁹

In contrast, new information that "merely clarifies or amplifies or makes insignificant modifications in an adequate EIR" does not require recirculation.¹⁰

In this case, the information in the June 22 Update is not the kind of “significant new information” requiring recirculation under CEQA. However, because of the reduction in the radius used in evaluating the Project’s potential health risks, the Committee believes it prudent to specifically seek public and agency comment on these and other changes to the analysis contained in the June 22 Update.

PUBLIC AND AGENCY COMMENT

We hereby **NOTICE** that any interested agencies or members of the public who wish to file comment on the revised analysis in the June 22 Update provide those comments **by 5:00 p.m. on July 22, 2022**. We specifically invite the Bay Area Air Quality Management District to provide any information or comments on this topic by July 22, 2022.

III. ORDER SHORTENING TIME

On July 6, 2022, Applicant filed “Vantage Data Centers’ Request for Special Business Meeting” (Motion for Expedited Review).¹¹ In the Motion for Expedited Review, “Applicant requests that the CEC “schedule a Business Meeting to approve the SPPE as soon as practical and before the next regularly scheduled Business Meeting in August.”¹²

When motions are made to the CEC, any response to the motion must be filed within 14 days.¹³ This time may be modified by order of the Presiding Member.¹⁴

Here, responses to the Motion for Expedited Review would be due July 20, 2022. In order to provide sufficient time for the Committee to consider the motion, the Committee hereby **GRANTS** *sua sponte* an order shortening time. Any response to the Motion for Expedited Review shall be filed **no later than 5:00 p.m. on July 19, 2022.**

IV. ORDER REGARDING UPDATED INFORMATION ON TRIBAL CONSULTATION

In the Draft EIR filed by Staff, the process of consultation with Native American tribes and nations is described.¹⁵ After noting a request for consultation from the Tamien Nation, the Draft EIR concludes by saying, “Consultation between the CEC and Tamien Nation is ongoing as of the time of this writing; CEC staff will update this results discussion in the final environmental impact report after the consultation concludes.”¹⁶ However, in the Final EIR, the text remains the same without an update to the outcome of the consultation process.¹⁷

The Committee hereby **ORDERS** Staff to update the Final EIR with information about the conclusion of the consultation process with the Tamien Nation. Staff’s update on this issue shall be filed **by 5:00 p.m. on July 22, 2022.** The Committee further **ORDERS** Staff to file any appropriate motion or stipulation for the updated information to be admitted into the evidentiary record **by 5:00 p.m. on July 25, 2022.**
