CATEGORICAL EXEMPTION, PLANNING AND LAND USE MANAGEMENT (PLUM) COMMITTEE REPORT, and ORDINANCE FIRST CONSIDERATION relative to a revised draft Ordinance amending Sections of Article 9, Chapter IX of the Los Angeles Municipal Code (LAMC) to create Cool Roof and Cool Surface requirements.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. FIND, based on the whole of the administrative record, that the revised draft Ordinance is exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines, Article 19, Section 15308 (categorical exemption for regulatory actions for protection of the environment), and that none of the exceptions under Section 15300.2 apply.
2. PRESENT and ADOPT the accompanying ORDINANCE, dated July 12, 2021, amending Sections 99.04.106, 99.05.106, 99.11.101, 99.11.102, and 99.12.101 of Article 9, Chapter IX of the LAMC to make local environmental and administrative changes to create Cool Roof and Cool Surface requirements.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At a Special Meeting held on August 31, 2021, the PLUM Committee considered a report from the City Attorney and revised draft Ordinance amending Sections 99.04.106, 99.05.106, 99.11.101, 99.11.102, and 99.12.101 of Article 9, Chapter IX of the LAMC to make local environmental and administrative changes to create Cool Roof and Cool Surface requirements. After providing an opportunity for public comment, the Committee recommended to adopt the revised draft Ordinance. This matter is now submitted to the Council for consideration.
