# Staff Report on the Lighting Controls Acceptance Test Technician Certification Provider 2016 Updates Review for the California Advanced Lighting Controls Training Program

### CEC-400-2016-019

The *2013 Building Energy Efficiency Standards* (2013 Standards), Section 10-103-A(d), requires that approved Acceptance Test Technician Certification Providers (ATTCPs) submit a 2016 Update Report to the California Energy Commission reporting what adjustments have been made to the training curricula, if any, to address adopted updates to the Standards.

Energy Commission staff has evaluated the training curricula adjustments and other application amendments that the California Advanced Lighting Controls Training Program (CALCTP) submitted in its 2016 Update Report for compliance to Section 10-103.1(c)3 of the *2016 Building Energy Efficiency Standards* (2016 Standards). Staff's evaluation was completed in accordance with the review and determination process outlined in section 10-103-A(f) of the 2013 Standards, as the 2016 Update Report was received prior to the January 1, 2017, effective date for the 2016 Standards.

Section 10-103-A(f)2 of the 2013 Standards requires the Energy Commission to give all interested persons a copy of staff's evaluation and provide reasonable opportunity for public comment. As such, the Energy Commission is posting the staff report detailing the review and evaluation of CALCTP's 2016 updates.
