The California Energy Commission (CEC) staff will host a workshop to provide information on the proposed STACK Trade Zone Park is to be located at 2400 Ringwood Avenue and 1849 Fortune Drive in San Jose. The project proposes an advanced manufacturing building, the SVY data center, the SVY backup generating facility, a parking garage, and related utility infrastructure. As the project meets the definition of a *project of statewide, regional, or areawide significance* under California Environmental Quality Act (CEQA) Guidelines, section 15206 (b)(2)(E), the CEC staff will host a public scoping meeting for the environmental impact report (EIR) as required by CEQA Guidelines, section 15082 (c)(1). Staff will also discuss with the applicant the outstanding responses to staff's data requests.

The public can participate in the meeting consistent with the remote attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### Agenda

The meeting will consist of soliciting comments from responsible and trustee agencies on the scope and content of the environmental information that responsible and trustee agencies require and discussions between staff and the applicant and any interested stakeholder agencies on the topic areas associated with outstanding responses to staff's data requests. After a brief project and CEC process overview, the anticipated order of topic areas to be discussed is Cultural and Tribal Cultural Resources, Greenhouse Gas Emissions, and Noise.

The CEC aims to begin promptly at the start time posted. The end time is an estimate based on the proposed agenda--the meeting may end sooner or later than the posted end time. Public questions will not be taken during the discussion of individual topic areas, but an opportunity for the public to make comments will be provided at the end of the meeting following the conclusion of the technical discussions.

## Background
