Dear Committee Members:

El Segundo Energy Center (“**ESEC**”) project owner, El Segundo Energy Center LLC (“**Project Owner**”), submits this status report for the ESEC Petition to Amend (“**Primary PTA**”) for proposed units 9-12 and the Petition to Amend certain air quality conditions of certification (“**AQ PTA**”).

On December 8, 2014, Project Owner submitted its comments to the Final Staff Assessment Part A (“**FSA Comments**”) for the Primary PTA. These comments are briefly summarized in Project Owner’s December 8, 2014 Status Report. We understand that CEC Staff’s responses to the FSA Comments are forthcoming. Project Owner is prepared to work with Staff to promptly address all such responses.

Project Owner looks forward to receiving the AQ PTA approval during the January 14, 2015 CEC Business Meeting. In addition, Project Owner awaits the South Coast Air Quality Management District’s (“**SCAQMD**”) issuance of the errata to the Final Determination of Compliance (“**FDOC**”). When SCAQMD releases the errata to the FDOC, we understand that CEC Staff will issue a complete FSA that incorporates SCAQMD’s analysis in the errata to the FDOC and release it for public comment.

During the December status conference, the parties discussed the necessity of scheduling additional status conferences before entering into the prehearing and evidentiary phase of the

ESEC proceeding. In light of the progress made to date, Project Owner prefers to move forward with the prehearing conference and to forgo the scheduling of any additional status conferences.

Project Owner will continue to work with Staff and all parties to find resolution on all issues.
