The California Energy Commission (CEC) will host a webinar to review the data collection requirements according to California Code of Regulations, title 20, section 1312. This data collected contributes to the CEC's staff analyses for the *Energy Efficiency Action Plan* and Senate Bill 350 – the Clean Energy and Pollution and Reduction Act (De León, Chapter 547, statutes of 2015) tracking progress reports.

The public can participate in the webinar consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The webinar may end sooner or later than the posted end time.

Agenda

CEC staff will present the form for non-utility PACE program administrators to submit data, along with a comprehensive review of the annual reporting instructions. Staff encourages PACE program administrators to review the forms and instructions beforehand and ask clarifying questions during the presentation.

Background

Property Assessed Clean Energy (PACE) is a financing program that enables residential and nonresidential property owners to pay for energy efficiency and renewable energy improvements on their property. PACE financing relies on the existing framework of residential property taxes by allowing property owners to repay the entire financing for a project through a special PACE assessment made on their property. Some of the energy efficient measures property owners can install include building insulation, HVAC, envelope improvements, windows, and lighting controls and some of the renewable energy improvements include rooftop photovoltaic and battery storage.

The CEC is directed by California Code of Regulations, title 20, section 1312 to annually collect PACE-financed project data from PACE program administrators. This data will provide the CEC with information that allows CEC staff to conduct evaluations of energy efficiency savings from PACE programs operating in California. It will also enable CEC staff to track progress and prepare projections towards meeting energy efficiency targets under the State's SB 350 goal of doubling energy efficiency savings by 2030.
