CHEERS intends to change its name from "ConSol Home Energy Efficiency Rating Services" to "California Home Energy Efficiency Rating System". The "CHEERS" acronym will continue to be used. There are very few places or materials where language referencing the current full name is used. The overwhelming majority of references and branding are done using the "CHEERS" acronym. Provided below is a list of materials where the current full name is referenced and will be revised:

Compliance Document PDF Digital Signature Certificate

Forms registered via the CHEERS data registry generate a final signed PDF. Applied to the final PDF is a digital signature. The digital signature, issued by DigiCert as a Code Signing Certificate, was generated using " ConSol Home Energy Efficiency Rating Services, Inc". Once the name change has been approved, the certificate will be re-issued using the revised name. The application of the digital signature is a singular process; the certificate need only be updated in one place and will apply to all generated documents.

Compliance Document PDF Notice

Forms registered via the CHEERS data registry generate a final signed PDF. Applied to the final PDF is a disclaimer that references the current full name. This will be revised after approval.
