

The Los Angeles Department of Water and Power (LADWP) is requesting a two-week extension to fulfill the CEC's 2009 IEPR data request for Electricity Demand Forecasts and Electricity Resource Plans. Thus, we are requesting an extension to March 2, 2009, from the original date of February 13, 2009.


Declaration of Oscar A. Alvarez

I, Oscar A. Alvarez, do declare as follows:


