## **Notice of Public Comment Period for ConSol Home Energy Efficiency Rating Services, Inc. Application Amendment Docket # 22-HERS-01**

The California Energy Commission (CEC) is providing interested parties with the opportunity to comment on the ConSol Home Energy Efficiency Rating Services, Inc. (CHEERS) Home Energy Rating System (HERS) provider's request for authorization to change its business name to California Home Energy Efficiency Rating Services.

### **Background**

Staff has reviewed the CHEERS request to change information pertinent to its HERS provider application and to amend its Residential Data Registry certification to reflect the name change. Staff has deemed the request complete. Staff plans to place the CHEERS request on the agenda for consideration at the February 15, 2023, business meeting. The proposed business meeting approval date is subject to change. If approved by the CEC, CHEERS will formalize the name change with the Secretary of State, submit its revised articles of incorporation to the CEC, and then conduct business under the new name. This includes compliance document registration under all previously approved Energy Code versions.
