I reviewed the corresponding comments you docketed in the business meeting docket which referenced 20 CCR 1104 and item 17 on the January 25, 2023 business meeting agenda, Petition to Request a Rulemaking Hearing (TNs 248536 and 248537).

> No items were added to the January 25, 2023 business meeting agenda after it was originally posted on January 13, 2023. On January 23, 2023 an allowable change was made to the agenda and it was re-posted on that date. The agenda was originally posted with an Item 2k, Petition to Request a Rulemaking Hearing, listed on the consent portion of the agenda.
