Notice of 2-Day Extension of Comment Period for the Draft Assembly Bill 525 Report: Developing a Permitting Roadmap for Offshore Wind Energy Development off the Coast of California

Docket 17-MISC-01

The California Energy Commission (CEC) is extending the public written comment period on the *Draft Conceptual Permitting Roadmap for Offshore Wind Energy Facilities Originating in Federal Waters off the Coast of California* from February 8, 2023, to February 10, 2023.

Assembly Bill 525 (AB 525, Chiu, Chapter 231, Statutes of 2021) requires the CEC to develop and submit to the Natural Resources Agency and the relevant fiscal and policy committees of the Legislature, a permitting roadmap that describes timeframes and milestones for a coordinated, comprehensive, and efficient permitting process for offshore wind energy facilities and associated electricity and transmission infrastructure off the coast of California.
