Dear Lithium Valley Blue Ribbon Commissioners and stakeholders, especially Nikola N. Lakic of Geothermal WorldWide, Inc.:

Thank you for presenting at the January 25th, 2023 California Energy Commission (CEC) business meeting. I understand per the end of the meeting that this Lithium Commission is a completely separate set of commissioners who are entirely volunteer and making independent decisions outside the CEC.

I also believe I heard Nikola N. Lakic of Geothermal Worldwide, Inc., suggest to the CEC Business Meeting Commissioners, during Public Comments, Agenda Item 22, Zoom archive recording near hour 4_44_56, to view "an important letter, about 60 to 62 pages, regarding asking for abolishment of the report of the panel of independent reviewers from University of Santa Cruz because it was travesty."

I do not know of the University of Santa Cruz other than the University of California at Santa Cruz, UCSC.

Since I am a graduate alumni from UCSC (and am concerned about this university's reputation), reviewed the 20-Lithium-01 docket and did not see any obvious UCSC report, saw several SDSU docket entries (which perhaps were what N. N. Lakic was referring to) and an abundance of docket entries by Nikola N. Lakic of Geothermal Worldwide, Inc., I think it might be appropriate for Nikola N. Lakic to share the 20-Lithium-01 TN docket number so that I and other UCSC students, faculty and alumni can find and review Nikola's cited UCSC submission more easily. I do not see one, but the submission might be under a different name other than UCSC.
