Perhaps the commission chair overlooks the definition of a proceeding when not ensuring documents submitted in any proceeding are filed with the Docket Unit in a timely manner.

Pursuant to 20 CCR sub section 1552(b) "Proceeding" means any meeting, hearing, workshop, conference, or visit, of the commission or its staff, at which public attendance is required or permitted.

Timely filing of documents would be before or during when a agenda item is considered in a proceeding.

Pursuant to 20 CCR subsection 1208(a), All documents submitted in any proceeding, whether by a party, committee, the commission, or any other individual or entity, shall be filed with the Docket Unit. Filing is complete when a document has been accepted by dockets staff or by the commission's automated electronic filing or commenting system. Documents that are not filed will not be deemed part of a proceeding's record.

Pursuant to 20 CCR subsection 1208(b)(3), Documents submitted to the presiding member during a public hearing will be accepted as of the date received, or as otherwise ordered by the presiding member.

Pursuant to 20 CCR subsection 1208(c), The responsibility to ensure that a document has been timely filed rests with the person, party, or entity that desires the document to be filed.
