Linda Barrera, Chief Counsel of the Energy Commission,

Perhaps you should talk with Kourtney Vaccaro as to my role in the commission making available a business meeting docket for the public's written comments. I believe Kourtney Vaccaro may tell you she thanked me for notifying the commission of the missing docket.

Perhaps you are aware that prior to April 5, 2019 a docket was not provided for the public's written comments in proceedings the commission refers to as business meetings?

Perhaps you are aware that meeting minutes were not made a record in a docket for proceedings that are business meetings prior to November 14, 2019. Only 34 meeting minutes filed since November 14, 2019.

Where are the signed minutes that shall be original evidence of actions taken at any meeting, including text of any resolutions adopted, prior to November 14, 2019?

My effort now is to ensure the public is not burdened with addition tasks in providing comments in a proceeding that is a business meeting.

I will now begin to list some public commenting issues, starting with easy to execute topics because there are existing laws to which you say you observe.

(1) Ensure everyone understands what a proceeding is and what timely filing of documents in a proceeding that is a business meeting is pursuant to 20 CCR subsection 2552(b) Definitions, and subsection 1208(a) Filing of Documents.

(2) Ensure pursuant to 11125.7(a) GOV-ARTICLE 9. Meetings 11120-11133, that proceedings that are business meetings provide an opportunity for members of the public to directly address the state body on each agenda item before or during the state body's discussion or consideration of the item.

(4) Ensure pursuant to Section 2556(g), the public adviser's duties to formally introduce public participants to the commission are achieved.

I believe these meeting issues can be corrected immediately to thereby provide the commission a more comprehensive record.
