**PETITION FOR CHANGE OF OPERATIONAL CONTROL**

Pursuant to Title 20, Section 1769(b)(1) of the California Code of Regulations (the “Regulations”), Bottle Rock Power LLC, a Delaware limited liability company (the “Project Company”), files this Petition for Change of Operational Control of the Bottle Rock Geothermal Power Plant (the “Project”).

On May 30, 2001, the Energy Resources Conservation and Development Commission of the State of California (n/k/a the California Energy Commission) (the “Commission”) approved Order No. 01-0530-07, to approve of the Transfer of Ownership from the California Department of Water Resources to the Bottle Rock Power Corporation, a California corporation (TN #20552).

On December 13, 2006, the Commission approved Order No. 06-1213-12, to approve of the Transfer of Ownership from the Bottle Rock Power Corporation to the Project Company (TN #38646 and refiled as TN #47894).

On May 17, 2016, Aaron Mandell, on behalf of Clean Energy Partners, LLC (f/k/a Base Load Clean Energy Partners, LLC), a Delaware limited liability company (“Clean Energy”), notified the Commission of an equity transaction where Clean Energy acquired all the equity interest owned by USRG Geothermal I, L.P., a Delaware limited partnership, in BRP Holdco, LLC, a Delaware limited liability company (the “HoldCo”), which HoldCo owned all of the membership interests in the Project Company (TN #211533).

On or around September 20, 2022, (i) Project Company, as Lessor, and Mayacma Geothermal, LLC, a Delaware limited liability company (“Mayacma”), as Lessee entered into a Lease Agreement dated September 20, 2022 (the “Lease”); and (ii) Project Company, as Seller, and Mayacma, as Buyer entered into an Asset Purchase Agreement dated September 20, 2022 (the “APA”).

As a result of the Lease and APA, Mayacma is to assume sole responsibility for operational control of the Project. In order to effectuate such transfer of operational control, Project Company provides the Commission with the following information pursuant to Section 1769(b) of the Regulations:

- (i.) in response to Section 1769(b)(1)(A) of the Regulations, Mayacma is to become the new operator of the Project pursuant to the Lease and APA and Project Company is to remain the owner of the Project pursuant to the Lease and APA;
- (ii.) in response to Section 1769(b)(1)(B) of the Regulations, Mayacma, as operator of the Project will be responsible for compliance with the Commission’s conditions of certification and

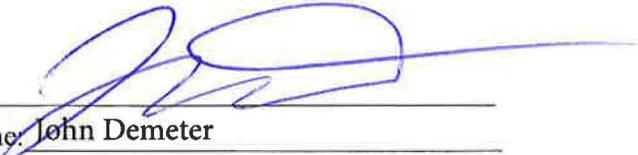
Mayacma understands the conditions of certification and agrees to comply with them; and

- (iii.) in response to Section 1769(b)(1)(C) of the Regulations, please see the Affidavit in Support of Petition for Change of Operational Control attached hereto as Exhibit "A" (the "Affidavit"). The Affidavit is a verified statement by an officer of Mayacma in the form required by Section 1707 of the Regulations that states Mayacma understands the conditions of certification and agrees to comply with those conditions.

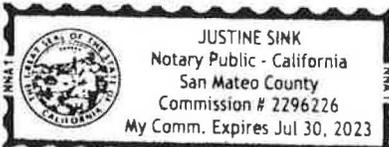

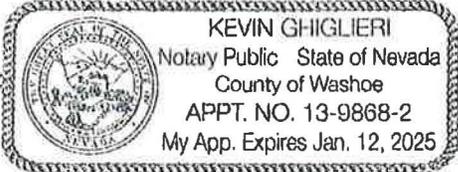
