Dear Energy Commission Commissioner's,

GOV-CHAPTER 3.5. Administrative Regulations and Rulemaking Sections 11340-11361 do not require a agency to have rulemaking hearings, if not requested by the public.

My rulemaking petition to amend 20 CCR subsection 1104(e) does not request any rulemaking hearings. 20 CCR Article 4. Rulemaking and Informational Hearings, Section 1221 Petitions does not apply to my petition.

My rulemaking petition pursuant to GOV Section 11340.6 requests to amend 20 CCR subsection 1104(e) by use of rulemaking proceedings pursuant to Article 5 (commencing with Section 11346). My petition should be considered under GOV Section 11340.7.

Once a regulation has been adopted, embellishments can not be utilized to add details or features not supported by the regulation.

The rules the Chief Counsel's Office staff are utilizing for distributing documents related to a agenda for a business meeting through the business meeting web site that are not filed with the Docket Unit pursuant to 20 CCR Section 1208 notwithstanding 20 CCR Subsection 1201(f) have not been provided by staff.

The rules the Chief Counsel's Office staff are utilizing for requiring the public to address the commission through a separate agenda item for comment on other agenda items on a continuing basis notwithstanding 20 CCR Subsection 1104(e) have not been provided by staff.

The rules the Chief Counsel's Office staff are utilizing for allowing staff to distribute documents for a agenda item for comment after the public's written comment period has passed, notwithstanding 20 CCR Subsection 1104(e) and 20 CCR Section 2553, have not been provided by staff.

Please reject the Chief Counsel's Office's proposed order 23-0228-05 and approve my petition and start rulemaking proceedings.
