The California Energy Commission (CEC) seeks public comment on the Draft Demand Side Grid Support (DSGS) Program Guidelines, Second Edition. The Draft DSGS Program Guidelines, Second Edition, propose modified rules for program participation including eligibility requirements, participation process, and incentive structure. Background

Assembly Bill 205 (Ting, Chapter 61, Statutes of 2022) created the DSGS program as part of the Strategic Reliability Reserve. The DSGS program compensates eligible and enrolled participants for upfront capacity commitments and per-unit reductions in net energy load during extreme events achieved through reduced usage, use of backup generation, or both. On August 10, 2022, the CEC adopted guidelines to implement the DSGS program. On January 27, 2023, CEC program staff conducted a workshop on lessons learned from the program launch and collected public comment. CEC staff has reviewed the comments and has prepared the Draft DSGS Program Guidelines, Second Edition, for additional public feedback.

CEC staff will be hosting a workshop on these Draft DSGS Guidelines, Second Edition, on April 26, 2023. After further public comments are received, staff will be reviewing and revising as appropriate in anticipation of possible adoption of revised program guidelines by the CEC at a future business meeting.
