Notice of Consideration to Adopt Third Edition Guidelines for California Schools Healthy Air, Plumbing, and Efficiency Ventilation Program May 31, 2023

As part of the California Energy Commission's (CEC) May 31, 2023, business meeting, the CEC may consider adoption of the *Third Edition Guidelines for the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Ventilation Program*.

Background

Assembly Bill 841 (Ting, Chapter 372, Statutes of 2020) enacted the School Energy Efficiency Stimulus Program, which is referred to as the CalSHAPE Program, and includes two grant programs: the CalSHAPE Ventilation Program and the CalSHAPE Plumbing Program. The CalSHAPE Ventilation Program provides funding to California schools to assess, maintain, and repair ventilation systems. The CalSHAPE Plumbing Program provides funding to California schools and state agencies to replace aging and inefficient plumbing fixtures and appliances with water-conserving plumbing fixtures and appliances. The current edition of the CalSHAPE Ventilation Program Guidelines was approved by the CEC on June 8, 2022, and both CalSHAPE Programs launched in fall 2021.

Proposed Third Edition Guidelines

The *Draft Third Edition Guidelines for the CalSHAPE Ventilation Program* (Draft Third Edition Guidelines) were posted for review and comment on March 29, 2023, and included the following changes:

- The addition of Upgrade and Repair Grants requirements for the second phase of program awards, provides funding for HVAC system repairs, replacements, and upgrades, and clarifying language on the additional funding allocated to the program from the Greenhouse Gas Reduction Fund (Abstract and Chapter 1).
- The addition of three new chapters providing project requirements, a description of the application process, and an explanation of the reporting requirements for Upgrade & Repair Grants (Chapters 5, 6, and 7).

Based on stakeholder feedback, CEC staff revised the *Draft Third Edition Guidelines*. The *Revised Draft Third Edition Guidelines for the CalSHAPE Ventilation Program* proposes further updates to Chapters 1, 2, and 5, including:

- Chapter 1, Section F – addition of language to clarify the initial payment amounts.
- Chapter 2, Section C – addition of language to the requirements that carbon dioxide monitors be mounted five feet away from a door or operable window.
- Chapter 5, Section C – deletion of the language limiting hybrid heating systems to climate zones 1 and 16.
