## **Notice of Consideration to Adopt Fourth Edition Guidelines for California Schools Healthy Air, Plumbing, and Efficiency Ventilation Program October 18, 2023**

As part of the California Energy Commission's (CEC) October 18, 2023, business meeting, the CEC may consider adoption of the *Draft Fourth Edition Guidelines for the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Ventilation Program* (Draft Fourth Edition Guidelines).

### **Background**

Assembly Bill 841 (Ting, Chapter 372, Statutes of 2020) enacted the School Energy Efficiency Stimulus Program, which is referred to as the CalSHAPE Program, and includes two grant programs: the CalSHAPE Ventilation Program and the CalSHAPE Plumbing Program. The CalSHAPE Ventilation Program provides funding to California schools to assess, maintain, repair, and replace ventilation systems. The CalSHAPE Plumbing Program provides funding to California schools and state agencies to replace aging and inefficient plumbing fixtures and appliances with water-conserving plumbing fixtures and appliances. The current edition of the CalSHAPE Ventilation Program Guidelines was approved by the CEC on May 31, 2023, and both CalSHAPE Programs began accepting applications in fall 2021.

### **Proposed Fourth Edition Guidelines**

The Draft Fourth Edition Guidelines includes the following changes:

- Removal of the limit on the number of applications a local educational agency (LEA) may submit each funding round for both Assessment and Maintenance (A&M) and Upgrade and Repair (U&R) Grants (Abstract, Chapter 1, Section A, and Chapter 3 and 6, Section B).
- Update to the timing of the payments for A&M Grants (Abstract, Chapter 1, Section A and F, Chapter 3, Section G).
