The substance or nature of the regulation are the guidelines governing the accounting system and tracking system pursuant to PUC section 399.25 and PUC section 399.21 and amendments to meet OAL's requirements for publication of the guidelines pursuant to GOV section 11343.8 to be determined through the requested rulemaking process.

The reasons for the request are to ensure through GOV section 11343.8 publication, everyone uses a single Energy Commission adopted source for the guidelines (the law) governing the accounting system implemented pursuant to PUC section 399.25 and the rules (the law) related to renewable energy credits (REC) tracking system established by the Energy Commission. Currently the public has no way to ensure they have access to laws governing ownership of environmental attributes in are not being double counted by anyone else.

The reference to the authority of the Energy Commission to take the requested action for publication of the PUC section 399.25 guidelines is PUC section 399.21 and 20 CCR sections 1221 and 1222 pursuant to GOV section 11343.8.

Any denial of this rulemaking petition shall be in writing and include a method to ensure the public has a way to ensure they have access to laws from a single Energy Commission adopted source for laws governing ownership of environmental attributes they have purchased to ensure the environmental attributes in are not being double counted by anyone.
