On December 27, 2023, pursuant to the Cal. Code Regs. (“CCR”) 20 § 1211.7 (2023), the Imperial Irrigation District (“IID”), by and through counsel, tendered for filing a Petition to Intervene in the above-captioned proceeding (“Petition”). This proceeding involves the application of BHE Renewables, LLC, which requests the California Energy Commission’s (“Commission” or “CEC”) authorization to construct and operate the Morton Bay Geothermal Project (“Morton Bay”) proposed in Imperial County, California. The Committee for this proceeding has not yet ruled upon IID’s Petition. Upon consideration, IID believes that its participation in this proceeding would be more effective not as a formal party to the proceeding but simply as an agency.

Accordingly, IID, by and through counsel, respectfully withdraws its December 27, 2023  
Petition.
