On November 8, 2023, the California Energy Commission (CEC) published the [draft staff report](#), which includes the proposed regulations and the draft staff analysis for landscape irrigation controllers, at <https://efiling.energy.ca.gov/GetDocument.aspx?tn=253050&DocumentContentId=88249>. The proposed standards for landscape irrigation controllers would be considered as amendments to the Appliance Efficiency Regulations (Title 20, Code of Regulations, Sections 1601 through Section 1609).through Section 1609).

In response to the comments received, the CEC is extending the deadline to submit written comments from January 8, 2024, to February 7, 2024. This provides interested parties with an additional 30 days to prepare and submit comments.
