Notice of Expanded Eligibility Under Funding Round Five of the CalSHAPE Ventilation Program Upgrade and Repair Grant

The California Energy Commission (CEC) is expanding the eligibility of Funding Round Five for the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Ventilation Program Upgrade and Repair (U&R) Grant. The eligibility of U&R Grants is currently limited to sites in an “Underserved Community” as defined in Chapter 1, Section C of the [CalSHAPE Ventilation Program Guidelines, Fourth Edition](#), (guidelines, available at <https://www.energy.ca.gov/publications/2023/california-schools-healthy-air-plumbing-and-efficiency-ventilation-program-0>), or near a Title V facility or busy roadway, as described in Public Utilities Code Section 1612. Beginning at 10:00 a.m. on March 19, 2024, eligibility will be expanded so that all sites that have completed an Assessment and Maintenance (A&M) Grant project in the HVAC Assessment and Maintenance Pathway or Limited or No Mechanical Ventilation Pathway will be eligible to be included in an application for a U&R Grant.

As a reminder, the Funding Round Five application deadline is 5:00 p.m. on May 31, 2024. Additionally, the CEC is not currently able to execute grant agreements after June 1, 2024, due to the final program reporting deadline of June 1, 2026, and the two-year project term provided for all grant projects, as described in the guidelines. **Please make every effort to submit complete and accurate applications well in advance of the May 31st deadline and submit notice of proposed award documents as soon as the application is approved to ensure a grant agreement is able to be executed prior to the deadline.**
