The California Energy Commission (CEC), the California Public Utilities Commission (CPUC), and the California Air Resources Board (CARB) will conduct a joint workshop to discuss the approach and implications of examining the non-energy benefits and social costs of potential resource scenarios to meet Senate Bill (SB) 100 (SB 100, De León, Chapter 312, Statutes of 2018) targets.

#### Agenda

The workshop will focus on approaches to incorporating non-energy benefits and social costs of potential resource scenarios into the SB 100 analysis. There will be presentations by CEC, CPUC, and CARB covering considerations in energy resource and climate planning (Scoping Plan, see details below under Background), and proposed approach to evaluating non-energy benefits and social costs in the 2025 SB 100 Report. Representatives from environmental and other stakeholder groups will participate in a panel on priorities for non-energy benefits related to SB 100 analyses.

#### Background

The 100 Percent Clean Energy Act of 2018 (SB 100, De León, Chapter 312, Statutes of 2018) establishes a target for renewable and zero-carbon resources to supply 100 percent of retail sales and electricity procured to serve all state agencies by 2045. SB 100 requires the CEC, CPUC, and CARB to develop and submit a joint-agency report to the legislature by January 1, 2021, and at least every four years thereafter. The requirement is codified in the <u>Public Utilities Code Section</u> <u>454.53</u>, and the full text is available at

https://leginfo.legislature.ca.gov/faces/codes\_displaySection.xhtml?lawCode=PUC&sectionNum=4 54.53.

#### The 2021 SB 100 Joint Agency Report, available at

https://efiling.energy.ca.gov/EFiling/GetFile.aspx?tn=237167&DocumentContentId=70349, published March 15, 2021, makes several land-use-related recommendations: (1) analyze projected land-use impacts of scenarios and opportunities to reduce environmental impacts in future analyses; (2) include non-energy benefits, such as land use impacts; and (3) coordinate future system modeling and land-use impacts with the Climate Smart Strategy called for in Executive Order N-82-20 and the Assembly Bill 32 Scoping Plan (Nunez, Chapter 488, Statutes of 2006) (https://ww2.arb.ca.gov/our-work/programs/ab-32-climate-change-scoping-plan).
