# Notice of Work Group Meeting #2 to Discuss Senate Bill (SB) 114 Funding for Zero-Emission School Buses and Infrastructure April 3, 2024

The California Energy Commission (CEC) and the California Air Resources Board (CARB) invite you to participate in the second public work group meeting to discuss funding for zero-emission school buses and infrastructure made available by Senate Bill (SB) 114 (Committee on Budget and Fiscal Review, Chapter 48, Statutes of 2023).

SB 114 appropriated a total of \$500 million to the CEC and CARB for the 2023-2024 fiscal year to fund zero-emission school buses and supporting infrastructure through grants awarded to local educational agencies. The CEC and CARB have named this appropriation the "Zero Emission School Bus and Infrastructure" (ZESBI) grants.

At this work group meeting, staff will discuss proposed ZESBI grant program requirements, including but not limited to: legislative requirements, application timeline, award amounts, eligible costs, and priority grantees. Staff encourage the public to participate in the work group and provide feedback on program design prior to the ZESBI grant program's application launch. The work group presentation will be posted to <u>CARB's Low Carbon Transportation Incentives webpage</u> (https://ww2.arb.ca.gov/our-work/programs/low-carbon-transportation-investments-and-airquality-improvement-program/low-0), and <u>CEC's Zero Emission School Bus and Infrastructure</u> Program webpage (https://www.energy.ca.gov/programs-and-topics/programs/zero-emissionschool-bus-and-infrastructure-program). The public can participate in the work group meeting consistent with the attendance instructions below. CEC and CARB aim to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The work group meeting may end sooner or later than the posted end time.

## Background

Senate Bill 114 (Committee on Budget and Fiscal Review, Chapter 48, Statutes of 2023), which amended Section 121 of Assembly Bill 181 (Committee on Budget, Chapter 52, Statutes of 2022), appropriated a total of \$500 million to CARB and the CEC for the 2023-2024 fiscal year to fund zero-emission school buses and supporting infrastructure through grants awarded to local educational agencies. The intent of the funding is to replace internal combustion school buses owned by local educational agencies with zero-emission school buses and provide complementary charging and fueling infrastructure.

Of the \$500 million, \$375 million in incentives will be awarded through CARB's Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project (HVIP) for zero-emission school buses. HVIP is the cornerstone of CARB's advanced technology heavy-duty incentives, providing funding since 2010 to support the long-term transition to zero-emission trucks and buses. The remaining \$125 million will be awarded to local educational agencies, through CEC's Zero-Emission School Bus Charging and Fueling Infrastructure Block Grant, for charging or fueling stations and related activities, including, but not limited to, equipment, site design, construction, related infrastructure upgrades, and workforce development and training.
