NOTICE OF DISADVANTAGED COMMUNITIES ADVISORY GROUP DIRECTION REGARDING EPIC INVESTMENTS IN COMBUSTION TECHNOLOGIES IN OVERBURDENED COMMUNITIES

At the regularly noticed meeting of the Disadvantaged Communities Advisory Group (DACAG) on September 15, 2023,¹ during Agenda Item 8 Electric Program Investment Charge (EPIC) Strategic Planning Process, a policy statement was adopted by the DACAG as follows:

- Member Adrian Martinez proposed the following motion²:
 - Part 1 is that the DACAG provide direction to stop investing in combustion technologies in overburdened communities.
 - Part 2 is direction to submit this direction to the docket or all of the dockets.
- Member Roger Lin seconded.
- Acting Chair Jana Ganion took a roll call vote, and the motion passed unanimously 7-0 of all members present.

The DACAG was established pursuant to Public Utilities Code section 400(g) to review and advise the California Energy Commission (CEC) and California Public Utility Commission (CPUC) on clean energy and pollution reduction programs and determine whether those proposed programs will be
