I am following up on three project notification letters submitted February 12, 2024, on behalf of my client, BHE Renewables and their project entities Black Rock Geothermal LLC, Elmore North Geothermal LLC, and Morton Bay Geothermal LLC. The letters are regarding three geothermal power projects (summing to 357 net megawatts) located southeast of the Salton Sea in Imperial County, California.

The three proposed geothermal power plants are located near or adjacent to existing and comparable geothermal power facilities outputting 345 megawatts. The new facilities would not cause new visual/aviation impacts that are not currently present in the proximal area. As requested, the Military Aviation and Installation Assurance Siting Clearinghouse coordinated within the Department of Defense (DoD) an informal review of the Elmore North Geothermal Project. The results of our review indicated that the geothermal project, located in Imperial County, California, as proposed, may have an impact on military operations conducted in the area.
