# ORDER GRANTING PETITION TO INTERVENE FILED BY SUPPORTERS ALLIANCE FOR ENVIRONMENTAL RESPONSIBILITY

Upon consideration of the Petition to Intervene (Petition)<sup>1</sup> filed by Supporters Alliance for Environmental Responsibility, (SAFER or Petitioner) in the application for certification (AFC) of the Black Rock Geothermal project (Project),<sup>2</sup> the California Energy Commission (CEC) committee designated to conduct proceedings in this matter (Committee)<sup>3</sup> makes the following findings:

- 2. The Petition contains the information required by the CEC's regulations.<sup>4</sup>
- 3. SAFER's Petition states it intends to participate in all topics relevant to the CEC's consideration of the Project including, but not limited to, project alternatives, environmental baseline, air quality and greenhouse gas impacts, impacts on biological resources, water quality and quantity impacts, public health and worker safety impacts, cumulative impacts, geologic hazards and resources, recreation impacts, compliance with all applicable laws, environmental baseline, alternatives analysis, and adequate mitigation measures. SAFER reserves the right to participate in other topics as well.<sup>5</sup>
- 4. No opposition to the Petition has been filed, and the deadline for such opposition was April 23, 2024.
- 5. Petitioner has demonstrated a bona fide interest in the Project and has demonstrated possession of information or expertise that may help the Committee in preparing a proposed decision.
- 6. Petitioner's stated interests are relevant to the above-captioned proceeding.
- 7. Intervention is granted at the Committee's discretion to the degree that it finds intervention reasonable and relevant. The Presiding Member or Committee may impose conditions on all intervenors' participation to promote the orderly conduct of the proceeding.

**THEREFORE**, the Committee **ORDERS** that the Petition be **GRANTED** and that Petitioner may participate on the following topic areas as requested:

The Committee further **ORDERS** that Petitioner's name be placed upon the Project's Proof of Service List as an intervenor. Petitioner may exercise the rights and shall fulfill the obligations of a party as set forth in all orders issued in the proceeding and California Code of Regulations, title 20, section 1211.7(a). Deadlines and other matters shall not be extended or changed by the granting of the Petition.<sup>6</sup>

Petitioner's intervention is subject to modification at the discretion of the Presiding Member or the Committee. The CEC welcomes and values intervenor participation in its energy facility siting process.
