The California Energy Commission (CEC) will host a hybrid in-person and remote-access hearing led by the CEC's lead Commissioner for energy efficiency, Commissioner J. Andrew McAllister. The purpose of this hearing is to receive public input on the proposed voluntary residential and nonresidential energy efficiency revisions to Appendices A4.2 and A5.2 of the California Code of Regulations (CCR), Title 24, Part 11, also known as the Green Building Standards Code or CALGreen.

The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The hearing may end sooner or later than the posted time.

Agenda

The CEC will present the proposed residential and nonresidential voluntary energy efficiency measures for CALGreen, Appendices A4.2 and A5.2, and provide the public with an opportunity to provide oral comments. A detailed meeting agenda will be posted prior to the hearing to docket <u>24-BSTD-02</u>.

Background

The Building Energy Efficiency Standards contained in CALGreen include voluntary energy efficiency requirements for newly constructed buildings, and additions and alterations to existing buildings. The CEC updates the CALGreen voluntary residential and nonresidential provisions every three years alongside updates by the CEC in the statewide mandatory Energy Code (Title 24, Parts 1 and 6) and updates by other state agencies for the rest of the California Building Standards Code (Title 24).

The CEC proposes to adopt changes to the voluntary Building Energy Efficiency Standards contained in CALGreen after considering all public recommendations, comments, and objections regarding the proposed changes in Part 11.

The CEC began the formal rulemaking for the proposed 2025 CalGreen update on May 17, 2024, with the publication of the Notice of Proposed Action (NOPA) by the Office of Administrative Law in the California Regulatory Notice Register. Prior to this publication, the CEC considered potential updates during the preceding two years in pre-rulemaking development of the proposed changes.

The proposed language and rulemaking documents have been posted on the CEC's 2025 Building Energy Efficiency Standards webpage located at energy.ca.gov/programs-and-topics/programs/building-energy-efficiency-standards/2025-building-energy-efficiency.

Oral comments will be accepted at the hearing. Written comments will also be accepted on the docket through July 1, 2024. The CEC appreciates receiving written comments at the earliest possible date. Instructions for providing oral and written comments included below.
