# Notice of Staff Rulemaking Workshop on Updates to the Power Source Disclosure Regulations June 11, 2024

Start Time 10:00 a.m. – End Time 1:00 p.m. Remote Only See Attendance Instructions.

The California Energy Commission (CEC) will host a rulemaking workshop to solicit feedback on proposed changes to the Power Source Disclosure (PSD) program regulations at California Code of Regulations, Title 20, Division 2, Chapter 3, Article 5 beginning with Section 1391, including changes required by Senate Bill (SB) 1158 (Becker, Chapter 367, Statutes of 2022) and Assembly Bill (AB) 242 (Holden, Chapter 228, Statutes of 2021).

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

The Lead Commissioner from the CEC may be present at the workshop but will not take action on any matters.

# **Agenda**

This workshop is part of the formal rulemaking process. The PSD regulatory package was submitted to the Office of Administrative Law (OAL) on Tuesday, May 7 and was published in the OAL registry on May 17. The workshop will include a presentation by CEC staff on the 45-day language of the proposed PSD regulations. Discussion items for the workshop will include:

- SB 1158 hourly accounting implementation
- Proposed updates to annual accounting
- Proposed additions to the power content label
- Updated reporting templates
- Other changes proposed to regulatory language

There will also be an opportunity for public comment at the workshop.

# **Background**

The PSD program was initially authorized by SB 1305 (Sher, Chapter 796, Statutes of 1997) and the CEC initially promulgated program regulations in 1998 at Cal. Code Regs. Tit. 20, § 1391 et seq. In 2019, the CEC adopted modifications to the regulations to implement AB 1110 (Ting, Chapter 656, Statutes of 2016), which included the requirement for a retail supplier to disclose the GHG emissions intensity for each electricity portfolio that it offers.

SB 1158 became law in 2022 and requires retail suppliers to begin reporting hourly loss-adjusted load and GHG emissions data to the CEC starting in 2028; the CEC is required to adopt rules on these requirements by July 2024. SB 1158 stipulates that the California Public Utilities Commission and the governing boards of publicly owned utilities may use hourly data to track progress toward GHG emissions reduction targets. As a result of this new legislation, the PSD program will be responsible for the reporting of power sources and emissions at both the annual and hourly level.

On December 7, 2021, CEC staff held a workshop to initiate pre-rulemaking activities for AB 242, which established deadlines for retail suppliers to post and distribute their power content labels. The workshop also addressed clarifying changes to the regulations, such as the reporting requirements for new community choice aggregators and the retirement of unbundled renewable energy credits. On September 26, 2023, CEC staff held another pre-rulemaking workshop to present initial draft regulations and request stakeholder feedback.

To launch formal rulemaking procedures, CEC staff has prepared draft regulations (express terms) to implement SB 1158's hourly accounting methodology and to update annual accounting rules under the PSD program. Additionally, the PSD program has developed draft reporting templates for annual and hourly reporting. These documents, along with other rulemaking documentation such as the Initial Statement of Reasons, will be posted in advance of the workshop in the <a href="docket">docket</a> (21-OIR-01) at https://efiling.energy.ca.gov/Lists/DocketLog.aspx?docketnumber=21-OIR-01.
