The California Energy Commission (CEC) will host a workshop to share the projected rulemaking process for the implementation of Assembly Bill 1373 (Garcia, Chapter 367, Statutes of 2023) (AB 1373) POU Capacity Payments. This includes reviewing the draft regulations, major milestones, and anticipated outcomes of the rulemaking process. A quorum of commissioners may participate remotely, but no votes will be taken.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

**Agenda**

Staff from the CEC will provide information on the proposed implementation of AB 1373 POU Capacity Payments. This will include an overview of the statutory mandates, milestones between now and the anticipated effective date, and the proposed methodology and calculation for capacity payments. CEC staff will walk through examples of what a potential capacity payment could equate to. The workshop will include a public comment period, and the CEC will request feedback on the draft regulations.

## Background

AB 1373 established a new fee structure for publicly owned utilities in the California Independent System Operator balancing area that fail to meet system resource adequacy requirements during a month where the Electricity Supply Strategic Reliability Reserve Program resources are dispatched to meet an identified reliability need and authorized the CEC to adopt regulations to implement the statutory provisions.
