The 2023 Power Source Disclosure (PSD) Annual Report due date has been changed from June 3, 2024 to **July 1, 2024** to accommodate retail suppliers that are impacted by ongoing software issues within the Western Renewable Energy Generation Information System (WREGIS). This postponement supersedes previous communication from PSD staff to retail suppliers about the WREGIS software issue. Staff continue to monitor the WREGIS software issue and will provide additional guidance as needed. California Retail Electricity Suppliers,

On April 29, 2024, Power Source Disclosure (PSD) staff sent an email to the program's current retail supplier contacts addressing the ongoing Western Renewable Energy Generation Information System (WREGIS) software issue. This communication updates that information.

To accommodate impacted parties, the 2023 PSD annual report due date has been changed from June 3, 2024 to **July 1, 2024** for all retail suppliers. No supporting documentation is needed to demonstrate the impact of the WREGIS software issues on the ability to timely submit the annual report. However, any retail supplier not impacted by this WREGIS issue is strongly encouraged to report by June 3, 2024. Staff are monitoring the WREGIS software issue and will provide additional guidance as needed.

California Retail Electricity Suppliers,

The Energy Commission (CEC) has posted the official 2023 Power Source Disclosure (PSD) Annual Report template on the PSD webpage at <https://www.energy.ca.gov/programs-and-topics/programs/power-source-disclosure/power-source-disclosure-resources-retail>.

California retail electricity suppliers are required to submit a separate Annual Report for each electricity portfolio offered the previous calendar year. Annual Reports are due by June 1st of each year. June 1, 2024, occurs on a Saturday; therefore, the CEC will consider Annual Reports provided to the CEC by **June 3, 2024**, as timely.

CEC staff are aware of a software issue within the Western Renewable Energy Generation Information System (WREGIS) causing some generators to generate an incorrect number of certificates, or not generate certificates at all. Some retail suppliers have voiced concerns about meeting the PSD Annual Report due date without accurate certificate information in their WREGIS accounts. CEC staff will work with the impacted retail suppliers to address the WREGIS certificate issuance delays, and set alternative submittal deadlines, on a case-by-case basis. To be considered for an alternative submittal deadline, the impacted retail supplier must provide the CEC with written documentation from their counterparty or from WREGIS, confirming that the retail supplier is experiencing certificate issuance delays. All other retail suppliers must submit their Annual Reports by June 3, 2024.
