The California Energy Commission (CEC) will host a remote-access workshop to provide information on program updates and new activities related to workforce training and development for zero-emission vehicles (ZEVs) and related infrastructure.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

The workshop will include staff presentations on new and recently completed projects funded by the Clean Transportation Program supporting zero-emission vehicle (ZEV) workforce training and development. CEC staff will introduce the *Draft ZEV Workforce Training and Development Strategy: A Roadmap for Clean Transportation Program Funding* and solicit public feedback regarding strategy objectives. There will be presentations from experts representing the charger maintenance and repair industry, as well as a discussion of training opportunities and skill gaps for charger maintenance and repair. The workshop will also include a public comment period. Background

Assembly Bill (AB) 118 (Núñez, Chapter 750, Statutes of 2007), created the Clean Transportation Program. The statute authorized the CEC to develop and deploy alternative and renewable fuels and advanced transportation technologies to help attain the state's climate change and clean air goals. AB 126 (Reyes, Chapter 319, Statutes of 2023) reauthorized the Clean Transportation Program through July 1, 2035, with a renewed emphasis on the development and deployment of zero-emission technology and fuels in the marketplace.

The Clean Transportation Program's workforce training initiatives are broad-based partnerships that leverage other public and private job training programs and resources. Annual investment plans identify funding for workforce training and development activities. There is currently \$8.4 million remaining in approved funding for workforce activities. Through Clean Transportation Program investments, the CEC intends to help cultivate an economically sustaining, equitable, and diverse workforce that will support the state's ZEV and ZEV infrastructure deployment policies.

Recent, active, or anticipated ZEV workforce funding activities under the Clean Transportation Program include:

- Inclusive, Diverse, Equitable, Accessible, and Local (IDEAL) ZEV Workforce Pilot Project Solicitation – Includes awards for 14 projects to develop curricula, tuition, and job placement assistance for ZEV training related to public transit, fleet operations, freight, and hydrogen refueling infrastructure. Grant recipients include community colleges, local governments, and community-based organizations.
- Advanced Transportation and Logistics Initiative at San Diego Community College District Expands alternative fuel and advanced vehicle technology training for college automotive programs. Funding was recently augmented to train incumbent fleet technicians and provide funding to expand existing medium- and heavy-duty truck programs to include zero-emission truck and infrastructure curriculum.
- Electric School Bus Training Project with the Advanced Transportation and Logistics Initiative at Cerritos Community College District – Develop curricula and provide electric school bus technician training to community college faculty.
- Electric Vehicle Infrastructure Training Program (EVITP) Training and Certification Program

 A \$3 million interagency agreement with the California Employment Training Panel to train
 and certify electricians through the Electric Vehicle Infrastructure Training Program.
