Dear Jessica L. Melms:

The California Energy Commission (CEC) received the Willow Rock Energy Storage Center<sup>1</sup> (applicant) repeated applications for confidential designation, dated May 31, 2024 (TNs 256630, 256640) covering the following documents:

- Heat and Mass Balance Diagram
- Property Owner's List

The applicant states that the above documents were previously determined by the CEC's executive director to be confidential for the life of the interconnection agreement (TNs 256366, 256447). The applicant further certifies under penalty of perjury that the documents submitted contain information that is substantially similar to information previously designated as confidential and all facts and circumstances relevant to the confidentiality of the information remain unchanged.

California Code of Regulations title 20, section 2505(a)(4) provides:

The Heat and Mass Balance diagram is designated as confidential for the life of the facility, consistent with the confidentiality period designated in the May 13, 2024 letter (TN 256366). The individual names associated with the addresses in the Property Owner's List are designated as confidential indefinitely, and all other information in the document will remain public, consistent with the original confidentiality designation in the May 17, 2024 letter (TN 256447).

The procedures for acting on a petition and criteria for disclosing or releasing records previously designated as confidential are set forth in California Code of Regulations, title 20, sections 2506-2508.
