This letter is to provide the California Energy Commission with a status update of the NEBB ATTCP program and to respond to the CEC's review and additional information request.

TRAINING, CERTIFICATION & REPORTING ACTIVITY:

As of 12/31/2023, NEBB has (4) certified employers and (34) certified technicians. This is an increase of (1) new employer and (29) new technicians.

Currently, there are (103) technician applications for certification. Of those, (29) applications are being verified, (1) are in the process of hands-on training, and (73) are in the process of written exams.

Currently, there are a total of (46) employer applications for certification. Of those, (20) applications are being verified, (24) are in the process of online training, and (2) are in the process of the written exam.

During this period there were (58) NRCA forms completed in (20) different Counties. The specific forms and counties in which they were performed is provided on page 3 of this letter.

None of the forms viewed through the desk audit were triggered or flagged by ESCO's audit feature. Therefore, there have been no quality assurance and accountability activities required.

NEBB did not need to take any actions to correct problems with ATT's field performance or ATE's.

The NEBB continues to meet the requirements of §10-103.2 as an ATTCP.
