## Subject: CSPTC Annual Report of the California State Pipe Trades Mechanical Acceptance Test Technician Certification Provider to the California Energy Commission.

California Energy Commission,

The California State Pipe Trades Council (CSPTC) was approved as an Acceptance Test Technician Certification Provider (ATTCP) for non-Residential Mechanical Acceptance Test Technicians and Employers on September 14, 2016.

We have approved Local Union Training Centers in San Francisco, Santa Rosa, Fresno, Los Angeles, Concord, San Jose, Vallejo, and Sacramento that are currently teaching the curriculum outlined in the latest update submitted by the California State Pipe Trades Council and approved by the California Energy Commission. As of January 1, 2024, we have approximately 128 certified Mechanical Acceptance Test Technicians (MATTs) and another 147 that are in various stages of fulfilling their requirements for certification. I have included an Appendix with these reports. As of January 1, 2024, the CSPTC has certified a total of 238 MATTs. 58 of these certifications expired in 2023. A total of 110 CSPTC MATT certifications have expired since we were approved in 2016.

As of December 31, 2023, we also have 64 Mechanical Acceptance Test Employers (ATEs). We continue to be proactive in seminars being conducted to bring contractors up to speed on the Title 24 CA Energy Code regarding Acceptance Test Technician Certification Providers for Non-Residential Mechanical Acceptance Test Technician Employers. The CSPTC has certified 144 ATEs. None of these certifications expired in 2023. A total of 80 certifications have expired since we were approved in 2016.

Independent oversight of the certification processes and procedures are administered by the ESCO Group. For the year of January 1 to December 31, 2023, ESCO has received no complaints, or CEC approved complaints, and has performed no audits for CSPTC certified MATTs and their acceptance testing (see Appendix B). CSPTC MATTs performed acceptance tests for 14 projects during this period with a total of 48 tests performed. Appendix B also includes a report from ESCO listing the agency, county location, type of project, and MCH

forms completed for the projects submitted to ESCO by a CSTPC certified MATT. This report also reflects the date the testing report was created in the ESCO system – we have only included reports submitted in 2023.

We believe this update certifies that the CSPTC ATTCP program continues to meet the requirements of section 10-103.2. If we can provide any further details, please let me know.
