Regarding: Compass Energy Storage Project (Laguna Niguel)

You absolutely cannot be serious about allowing a lithium battery storage facility in the I-5 corridor in Laguna Niguel. This has already been rejected by the local government and now you are being asked to override the local authorities. That is not America! This is a horrible idea on multiple levels: Public Safety, Environmental Concerns, Homeowner Property Value Impact, Fire Danger, Historical Landmark Threat, etc. I implore you to shut this idea down. A project like this belongs far away from any people, waterway, or other natural habitat. Let's break this down for this commission...

Public Safety - literally 2,000 feet away and over a scrub brush covered hillside sits dozens, if not 100+, milliondollar plus family homes with children, pets, and livelihoods. Imagine how fast a fire will spread and engulf these homes when a lithium cell catches fire.
