RE: REPEATED APPLICATION FOR CONFIDENTIAL DESIGNATION for Mojave Solar LLC Responses to Data Requests for Petition to Amend for the Addition of Two New Evaporation Ponds at the Mojave Solar Project (09-AFC-05C)

Pursuant to Section 2501 et seq., of Title 20 of the California Code of Regulations, Mojave Solar LLC (Mojave Solar) hereby submits this *Repeated Application for Confidential Designations* on behalf of the Mojave Solar Project ("MSP") (09-AFC-05C), hereinafter "Application." This includes charts with monthly information provided in direct response to Data Request Set 2, request number DR2, and granular inflow, outflow and energy production data provided in Exhibit "A" to Mojave Solar's responses.
